DEAR STUDENTS AND PARENTS:

Welcome to our 2022-23 Dance Year! We hope your summer has been fun and enjoyable and we look forward to seeing you soon. We are looking forward to a new and healthier Dance season with no major interruptions. Classes will resume Tuesday, September 6, 2022.

In order to develop their skills more fully, each student should have hair neatly pulled back and will be advised of the **proper shoes & dress required** for each class. We carry the proper shoes at the Studio and if we don't have their size in stock, we will have them by September. Please have your child's correct size by the evening of registration, and we will be glad to purchase them for you. We know we could get you exactly what you need at reasonable prices. PINK TIGHTS are required for ALL Ballet classes. (**PLEASE SEE MISS CHRIS FOR YOUR CHILD'S CORRECT DANCE ATTIRE**). You may purchase leotards from our selections for your convenience.

CLASS FEES ARE AS FOLLOWS:

Baby Rhythm/Ballet/Jazz/Tap/Lyrical/Hip-Hop1 hr. per week - \$48 per month (1class)

Acrobatics.....1 ½ hrs. Per week - \$72 per month

All 1-hour classes will be \$48 per month (\$480 per year tuition) **OR** \$46 each (\$460 each per year tuition) for 2 or more classes.

Acrobatic classes (1- ½ hrs. per week) will be \$72 per month (\$720 per year) or \$69 per month along with any other class. (**ALL CLASSES PAID IN 10 EQUAL MONTHLY INSTALLMENTS**). *Insurance/Registration fee (\$50 or \$45 ea./siblings) must be paid with September.

DISCOUNTS: When there are two or more classes being taken, or 2 or more siblings, you will get One/ the same discount.

REGISTRATION: In Person – **Tuesday, July 26, 2022 AND August 9, 2022 from 6:30 to 8:30 PM.**

Payments in person can be made by credit card (must add 3% for Square), check or in cash. You may also use Zelle.

By Mail – If you **do NOT** wish to wait in line on Registration night or cannot make it, please feel free to **MAIL** enclosed registration form and check (along with Waiver) to reach us by Tuesday, August 9, 2022. (All charges must be completed at the Studio).

Fee – At time of registration - September Class (Paid in FULL) plus \$50 (\$45 each for 2 or more siblings) for cost of Insurance/Registration from September 2022 thru August 2023. **ALL FEES NON-REFUNDABLE.**
